
Double Honors for Saunders in 1983

The citation given to John this past January read, "in recognition of his dedication to the heavy construction industry and his unselfish involvements in industry and community affairs".


Six Moles to Receive Life Membership on May 4th

Honorary Member Dead at 84

GEORGE R. BROWN, 1968 Non Member Recipient of The Moles' Award for outstanding achievement in construction died at St. Luke's Hospital in Houston, Texas on January 22, 1983.

Mr. Brown, retired Chairman of the Board of Brown & Root, Inc., was born in Belton, Texas on May 12, 1898. He received a degree in mining engineering from the Colorado School of Mines and became affiliated with Anaconda Copper Company. Badly injured in a mine cavein while working in Butte, Montana, he returned to his native Texas to recuperate. He joined the contracting firm which his brother, Herman and brother-in-law, Dan Root had founded in Austin, Texas. When Dan Root died in 1929, Herman and George incorporated what would become one of the world's largest and versatile construction and engineering companies.

On January 24, 1968, The Moles cited George R. Brown "in recognition of his leadership and foresight which has created an international organization of constructors and engineers performing civil and military works, unsurpassed in diversification and magnitude". At that time, in accepting his Award, George Brown said, "I am moved and complimented by your words - deep in a man's heart, he carries pride for his achievements, as well as regrets for his mistakes. But to sit before The Moles and hear this high praise is heart-warming. To be honored by the most ingenious heavy constructors in the world is a mark of success".

Amassing a fortune which made him one of the wealthiest men in the United States, he was one of Texas' most generous philanthropists, giving millions to Rice University, Southwestern University and various cultural programs through a foundation established by him and his late brother, Herman.

EUGENE J. LYNCH died on February 15, 1983 in Colorado. He was 78.

A member of The Moles since 1960, Mr. Lynch was highly regarded in the field of subsurface exploration. He was elected a member emeritus in 1971 after his retirement and some time thereafter moved to Colorado.



Heydon Retires As Chief Engineer of the New Jersey Turnpike Authority



HOWARD S. HEYDON has recently retired as Chief Engineer of The New Jersey Turnpike Authority after thirty years of service to that agency. He was Chief Engineer from 1967 to April 1, 1983; and prior to that served as Director of Maintenance from 1961 to 1967; and Specifications Engineer from 1953 to 1961.

Howard was born in Jackson, Michigan, then moved to Long Island, N. Y., where he completed public schools and began his college education. During World War II he served as a radar operator on B-29 bombers in the Far East and won the Air Medal with three Oakleaf clusters and the Distinguished Flying Cross. After the war he returned to college and received the degree of Mechanical Engineer from Stevens Institute of Technology. He also held engineering positions with the Port Authority of New York and New Jersey and Grumman Aircraft Engineering Corporation.

He and his wife, plan soon to move to Florida's west coast in serious pursuit of boating.



RALPH A. FLETCHER died at his home in Goffstown, New Hampshire on February 11, 1983. He was 87.

Born in Westford, Massachusetts on November 24, 1895, Ralph graduated from Lowell High School and earned his degree in engineering at Massachusetts Institute of Technology, class of 1916.

He worked more than 75 years for the H.E. Fletcher Co., starting summers as a tool and water boy in his early youth and at the time of his death, as Chairman of the Board.

The granite quarry and finishing plant in Westford was started by his father in 1881. In 1916, Ralph and his brother, Harold assumed its management. During his career, he introduced many of the tools and processes now utilized in the industry. The granite products of this company have become a part of many important buildings, bridges and highways in and around major cities in the eastern section of our nation including a building in the U.S. Naval Academy in Annapolis, the U.S. Navy War Academy in Newport, Rhode Island and in Washington, D.C., the new Senate Office Building, the Department of Labor Building, the Smithsonian Institute, the Theodore Roosevelt Memorial, the Archives Building, the Federal Trade Building, part of the Immaculate Conception church, Quincy Market and several buildings in Boston, including Harvard College, Boston College and Boston University.

Ralph was a member of The Moles for over forty years becoming a member emeritus in 1962 after twenty years. In 1982 he received his Life Membership.



RALPH S. SIEGRIST died on December 21, 1982 after a long illness.

Ralph was a Mole member since 1943. During that period he was an Explosives Engineer for Hercules Powder in their Contractors' Division. Shortly thereafter he joined Commercial Shearing & Stamping Company of Youngstown, Ohio as Sales Engineer in their Fabricated Tunnel Support Department where he remained until his retirement in 1968. He received his 25 Year Certificate in November 1968; served as Sergeant-at-Arms for The Moles during the period from May 1, 1971 to April 30, 1972; and became a Member Emeritus in 1976.

EDWARD G. JOHNSON died on December 1, 1982 in Florida where he had spent most of his later years.

Ned Johnson was an Officer of the Arthur A. Johnson Corporation, then prominent heavy construction firm specializing in subway, tunnel, foundation and underpinning, when he became a member of The Moles in 1951. He immediately became actively involved serving as Treasurer, Trustee, and Vice Chairman and Chairman of the Award Committee. After his retirement from construction he was elected a Member Emeritus. He received his 25 Year Certificate from The Moles in 1976.

E. DONALD PHINNEY died on April 1, 1983 in the North Fairfield Geriatric Center in Connecticut. He was 70.

Born in Wellesley, Massachusetts, Don had been a Darien resident for 20 years. He was a graduate of Dartmouth College class of 1933, the Roxbury Latin School and the Thayer Engineering School. His long career covered all phases of heavy construction and in particular he had vast experience in tunnel work both in

SIDNEY P. GILBERT died on January 10, 1983 at Nassau General Hospital on Long Island after a long illness. He was 69.

A 1935 civil engineering graduate of City College of New York, Sid was a native New Yorker.

Following twenty years of foundation construction experience, in 1955 he joined Underpinning & Foundation Co., Inc., and became President of the firm in 1959. From 1960 until he sold the company to Alpha Portland Industries in 1973 he was President and Owner with a scope of operations including underpinning, and unusual and often unique pile installations primarily in the New York City Metropolitan area. Some of the notable projects done by the firm during Sid's tenure were: foundations for the General Motors building on Fifth Avenue, Co-Op City, Lefrak City, and the State Office building in Harlem.

Sid's practical know-how was well known. He introduced the use of the Sonic Hammer in the New York area in 1963 and helped develop the famed Cobi Mandrel widely used in driving cast-in-place piles, adding to the wider choice of pile types available to the design engineer.

Long active in the City College Fund, he was its President and later Chairman of the Board. In 1973, he was one of City College of New York's distinguished alumni chosen to receive a special medal commemorating the 125th anniversary of the College.

He served The Moles as Trustee during the period from May 1, 1971 to April 30, 1973. In November 1980 he received his 25 Year Certificate from The Moles having been elected to membership in 1955.
