

Charlie Vachris graduated from Yale University with honors in 1961 and worked one year as a design engineer for Praeger-Kavanaugh-Waterbury in New York City. Thereupon, he spent two years as an officer in the U.S. Army Corps of Engineers at Fort Knox, Kentucky. He served as the Engineering Officer for the 160th Engineer Group (Construction) and subsequently for the 538th Engineer Battalion (Construction). After completing his military service in 1964, Charlie took the position of Vice President and eventually President of Vacar Construction Corporation, a family owned firm specializing in heavy underground and marine construction in the New York Metropolitan Area.

Charlie attended Columbia University School of Engineering and received his Master Degree in 1968.

With Vacar Construction Corporation he was involved with the construction of several large piers and wharves in Brooklyn, Port Newark and Port Elizabeth for the Port Authority of New York and New Jersey. The firm also constructed the foundations for the Cross Bay Parkway Veterans Memorial Bridge in Queens.

In 1979 Vacar went out of business and Charlie joined the Edward B. Fitzpatrick Corporation as Vice President of Engineering and Estimating. In 1982 he started the firm of Charles F. Vachris, P.E., Consulting Engineers, providing a comprehensive range of engineering services for contractors, private and public owners, municipalities and other design professionals. The firm specializes in the fields of heavy foundation and marine construction.

Charlie has been active in professional organizations including the National Society of Professional Engineers, the American Society of Civil Engineers and the American Consulting Engineers Council.

Since becoming a Mole in 1979, Charlie has served as a member of the Finance Committee, as treasurer, as Vice-Chairman and Chairman of the Awards Committee and as First and Second Vice President.

Charliie has also been active in community affairs, having served as Trustee of his village. He and his wife Gay have five sons, three of whom are married and have four grandchildren.

# A MOMENT OF SILENCE

WILLIAM J. HUGHES, of Hughes Brothers, Inc., died on July 30, 1995 at the age of 83. He was the third generation of the family to oversee the Hughes Marine Firms and had become a member of The Moles in 1951. His son William J. Hughes, Jr. continues to represent the firm as a member of The Moles.

The Moles' office learned of the death of JOHN C. MAXWELL in November 1995. He became a member of the Moles in 1938 and was the most senior of Moles' members at the time of his death at the age of 89. He had lived for many years in Las Vegas, Nevada.

Another long time Moles' member, WARING MIKEL, died on March 1, 1996 When he became a member of The Moles in 1947 he was employed by the Taconic State Parkway Commission. He then went on to a career with the National Park Service. He was 96 at the time of his death.

THOMAS H. O'CONNOR, JR., became a member of the Moles in 1977 at the age of 70. He was President of Thomas H. O'Connor & Co., Inc., a prominent Boston mechanical contractor. He died on August 2, 1995 at the age of 87.

PHILIP H. RECHEL spent his career with Martin Piling Company where he was President at the time of his retirement in 1988. The firm provided timber piling for projects from New England to the Philadelphia area. Phil was a very active Moles' member and attended the 1995 Moles Winter Meeting. He was 74 at the time of his death.

When he became a member of The Moles in 1961, JAMES H. RECK was with the Insurance Company of North America. He remained with the company as Director of Heavy Construction until his retirement in 1972. He continued to live in Freehold, New Jersey and had taken on a hobby of building scale models of Civil War cannons which were displayed in several museums.

## MOLES MEMBERS AID OAKPOINT RAIL LINK REDESIGN

A constructability review team which included several Moles' members played a vital role in the redesign of the Oak Point Rail Link Connection. Their efforts were instrumental in achieving a project which was both biddable and buildable.

The Oak Point Rail Link Connection is a 1.8 mile long railroad trestle along the Bronx shore of the Harlem River in New York City. It is the final segment of freight access improvements between the western United States and downstate New York and New England. It will eliminate conflicts between commuter rail and freight operations and provide vertical clearance improvements required to accommodate modern container car equipment.

The New York State Department of Transportation

(NYSDOT) had previously awarded a contract for the construction of the Oak Point Rail Link. That contract was ultimately terminated due to problems encountered during construction of the foundations. Berger, Lehman Associates, P.C., in association with Sidney M. Johnson Associates, was selected to

prepare revised contract documents for the completion of construction. The challenge of the redesign was to maximize the already completed construction while achieving a constructable solution. One of the most critical tasks was determining how to construct the pier foundations in difficult geological conditions.

The NYSDOT required that the redesign team include experienced construction people. Thus John W. Fowler, a marine consultant and formerly an executive of Tidewater Construction Corporation, Jerry Neumann and George Pretat of Spearin, Preston & Burrows and Louis Berger of Louis Berger International were brought on board to provide hands on input to the redesign. Having a construction contractor as part of the design team represented a landmark for the NYSDOT. The NYSDOT required that Spearin, Preston & Burrows agree not to bid the project. These members of the constructability team are long time Moles' members.

The original design included 36 inch diameter battered caissons for four legged pier foundations (quadropods) driven through a permanent steel bracing frame and socketed into bedrock. The installation of 72 inch monocaissons socketed into bedrock was also part of the original design. Rocks and boulders encountered during construction made the installation of the caissons through the bracing frame sleeves very difficult. Socketing the 72 inch caissons into the bedrock was a problem. Difficulty was encountered in effecting a seal and there was soil wash-in in the rock socket.

The redesign eliminated the requirement to batter the 36 inch caissons and relied rather on lateral earth support. Rock sockets for these caissons were eliminated by founding the caissons in the overlying

glacial till. Bracing frames were eliminated where they were not required for structural support and the number of 72 inch diameter caissons to be installed was minimized.

The constructability team made a number of recommendations including the following: a preconstruction

pile driving and load testing program to confirm the redesign and to provide additional information to bidders; that bidders be fully informed of the experience gained during the original construction program; the establishment of proper payment items to allow for the variable conditions likely to be encountered. These and other recommendations of the constructability review team were adopted by the NYSDOT.

The NYSDOT awarded a \$51 million dollar contract to John P. Picone, Inc. to complete construction and the work is nearing completion.
