TIMOTHY BARNARD, Chairman of Barnard Companies, Inc., Bozeman, Montana, will receive The Moles Non-Member Award for Outstanding Achievement in Construction and **RAYMOND R. ONEGLIA**, Vice Chairman of O & G Industries, Inc., Torrington, Connecticut, will receive The Moles Member Award. The awards will be presented at The Moles Annual Award Dinner, to be held on Wednesday evening, January 28, 2015, at The New York Hilton Hotel.

TIMOTHY BARNARD was born on November 19, 1949, in Paterson, New Jersey. Tim's first job, at age 15, had him working in a ditch with the family owned construction business. He attended Villanova University; Gonzaga University, Florence, Italy; and Sophia University, Tokyo, Japan. During his early 20s, he also traveled overland from Japan to Western Europe.

In 1975, Tim moved to Montana with an idea that he could start his own construction company, much like his

Ray was the grandson of Andrew Oneglia, who founded O&G in 1923, with his friend and business partner, Flaviano Gervasini. Ray commenced working for the company during summers while still in his teens, and at age 16, served as a

After completing his studies at Stanford University (BSCE '94) and University of California, Berkeley (MSCE '96), Chris joined the family construction company founded in 1946 by his grandfather, WILLIAM F. TRAYLOR. In 1979, THOMAS W. TRAYLOR, succeeded his father as leader of the company. Both William and Tom were members of The Moles; Tom received The Moles Member Award in 2010.

Chris' first construction assignment was as a field engineer on the South Bay Ocean Outfall in San Diego, California. From there he moved on to other tunnel and heavy construction projects and ultimately returned to Evansville, where he now serves as Co-President of the company along with his brother Mike. Chris oversees the corporate headquarters in Evansville, Indiana as well as the company's National Heavy Civil Division, which focuses on marine and bridge work.

In recent times, the company's projects were principally in the middle and western portions of the country. Since 2009, Traylor has been a JV partner in the following projects: East Side Access project in Queens, NYC; the 86th St. Station of the Second Avenue Subway in NYC; and the \$3 Bil. Tappan Zee Bridge Reconstruction Project.

Chris and his wife, Niki have four children: Gwyneth (9), Marshall (7), Sydney (5) and Courtney (3).

mother and father had in 1946. He had \$1,000, two shovels, a pick, and all of his worldly possessions in the cab of his pick-up. His grandmother loaned him the \$3,500 to cover his first bond on a \$17,000 project.

Since then, he has led his company through steady growth into multiple sectors. What started as an earthmoving and utility pipeline enterprise, now encompasses risky, remote and complex projects including the following: constructing a lake-fed cooling system at Cornell University; raising a 1950s-era, 145 foot-tall concrete arch dam by 83 feet in a steep narrow canyon on an Alaskan island; assembling an intake structure 270 feet below the water's surface in central Oregon; and renovating and expanding the world's first wholly underground powerhouse in Washington State.

Barnard's current projects include: the three-year, \$233 million twin TBM tunnel Central Subway Tunnel Project in San Francisco, A JV with Impregilo and S.A. Healy with Barnard as the managing partner; the seven-year, \$1.4 billion Keeyask Generating Station project in Gull Rapids, Manitoba, a joint venture with Bechtel and EllisDon; and a three-year, \$88 million dam raise and hydropower expansion for the City and Borough of Sitka, Alaska.

Today Tim Barnard serves in an active role as Chairman of the Board in this privately held company with approximately 50 employee stockholders and continues to be involved with all major decisions.

Tim has been a very strong and generous supporter of Montana State University, where he was honored with an Honorary Doctorate in 2011; a supporter of the University of Montana; and numerous, local charitable organizations.

Today, Tim Barnard and his wife Mary reside in Bozeman, Montana. Their six children and their families live throughout the western United States.

foreman and scraper operator on the Colebrook Dam project.

Ray earned a Bachelor of Science Degree from Union College in 1970, and immediately thereafter began full-time employment with the company, and took on full responsibility for the Boise Cascade project: a sixteen mile road and sewer project. Other early projects included the rebuilding of Ct. Route 7 from Danbury to Brookfield and the resurfacing of I-84 from Newtown to Danbury.

Ray has been instrumental in the acquisition and development of several rock quarries and construction material yards that has made O&G one of the most diversified construction companies in the northeast and a prime construction material supplier throughout the state of Connecticut.

Ray has led the expansion of O&G's sights well beyond Connecticut by establishing a good working relationship, first with Perini Corporation, constructing a lock and dam in Louisiana and a nine mile tunnel under the City of Chicago and then with Tutor-Saliba (subsequently Tutor Perini Corp.), constructing a rail line through the Alameda Corridor in Los Angeles and the construction of a runway at Los Angeles International Airport (LAX). Ray has served on the Board of Directors of Tutor -Perini since 2000.

Ray Oneglia has made significant contributions to the Connecticut Construction Industry Association (CCIA). He has served as Chairman, Head of the Legislative Committee and Head of various labor negotiation committees.

Today, through Ray's, his brother David's, and his cousins' leadership, vision and mentoring, O&G is recognized as one of largest and most respected construction companies in the Northeast.

Ray is a life long resident of Litchfield County, Connecticut, where he makes his home with his wife Ellen. Ray has three children, Jennifer, Elizabeth and Brad; and five grandchildren.

CHARLES F. VACHRIS

One of The Moles finest, 1996 President, **CHARLES F. VACHRIS**, died suddenly while playing basketball on October 7, 2014, at the age of 75.

Upon graduating from Yale University with an engineering degree, and service in the Army Corps of Engineers, he joined the family construction company, Vacar Construction Company. In 1982, he established Charles F. Vachris, P.E., Consulting Engineer (in 2001 changed to Vachris Engineering, P.C.) where he served as President until his untimely death.

Charlie was a very faithful supporter of Moles activities: the Award Dinner; the Clambake (where he traditionally captained the Engineer's team); and the Florida Winter meeting (being the only Moles member, along with his wife Gaye, to attend every Winter Meeting since its inception in 1995). He and Gaye were acknowledged to be the dance champions of The Moles.

One of the country's most experienced tunnel constructors, **JAY E. CARLSON**, died on July 22, 2014, at the age of 72. He was most recently employed by Obayashi Corp. Earlier employment was with S.A Healy Company, where he served as Senior Vice President.

A C.E. graduate of Union College, **RICHARD W. GUNN** died on September 30, 2014, at the age of 93. His career was principally with Seelye, Stevenson Value & Knecht, where he was a long time partner.

RAYMOND A. JONES, formerly Executive Vice President of J.A. Jones Construction Company, died on June 26, 2014, at the age of 89. J.A. Jones, located in Charlotte, North Carolina, was for many years one of the nation's premier construction companies.

GENNARO LIGOURI commenced his career in construction with Schiavone Construction Company and then joined Slattery Construction Company, subsequently becoming a part of Skanska. He died on November 11, 2014, at the age of 76.
